CONSUMER PRICE INDEX (CPI) MONTH – ON – MONTH REPORT FOR AUGUST, 2018.


The Consumer Price Index (CPI) Month – on – Month Inflation rate was -0.68% in August 2018, down by 1.89% from 1.21% recorded in July 2018.

The Urban Inflation Rate was -0.14% in August 2018, down by 1.51% from 1.37% recorded in July 2018. The Rural Inflation Rate was -1.24% in August 2018, down by 2.53% from 1.29% recorded in July 2018.

The fall of the inflation rate in August 2018 may be as a result of additional farmers fresh harvest of farm produce which lead to increase in supply and price reduction in the market as well as reduction of major household applied.

The Top Five Absolute contribution to the CPI Inflation Rate included: Major Household Applied (-0.95) %, Potatoes, Yam and Other Tuber (-0.33) %, Audio Video Photographic (0.20) %, Shoes and Other Footwear (0.20) % and Oil & Fat (0.10) %.

The highest contribution to the decrease of August 2018 month-on-month inflation rate was recorded in Major Household Applied (-0.95) %.
