CONSUMER PRICE INDEX (CPI) FOR APRIL, 2020.

The CPI Year-On-Year Inflation Rate for Kaduna State accelerated to 11.37% in April, 2020. This was 0.09% higher than the rate recorded in March, 2020 11.28%.

Accordingly, Inflation continued in April due to recent restriction of movement, thus causing consumers to spend primarily on essential Goods and Services which leads to the price hike in the Food Items and other commodities.

The report implies a quick rise in the prices of overall goods and services in the economy, as a result of lockdown effect for Covid-19 pandemic and the global oil crisis.

The latest increase in the Inflation rate signifies that the purchasing power of consumers to buy goods and services reduced.

This implies that the ability of consumers to buy the same quantity of goods with the same Income level has worsened within the period and economic activities deteriorated.

The CPI Month – on – Month basis in Kaduna State shows that the State Index stands at 203.32% in April 2020. The urban Index recorded 198.39% while rural index recorded 205.81% in April 2020 respectively.

The State CPI Month – on - Month Inflation rate was 12.20% in April 2020, up by 10.64% from 1.56% recorded in March 2020. The Urban Inflation Rate was 13.41% in April 2020, increased by 9.89% from 3.52% recorded in March 2020. The Rural Inflation Rate was 11.97% in April 2020, increased by 10.54% from 1.43% recorded in March 2020.


The Increase of the Month-on-Month Inflation rate in April 2020 was as a result of Increase in prices of Major Household Applied, Bicycles, Garments, Bread and Cereals and Vegetables

The Top Five Absolute contribution that influenced the Increase of the Month-on-Month April CPI Inflation Rate included: Major Household Applied 6.58%, Bicycles -1.39%, Garments 1.23%, Bread and Cereals 1.23% and Vegetables 1.07%.

The highest contribution to the Increase of April 2020 Month-on-Month Inflation rate was recorded in Major Household Applied with 6.58%.


