CONSUMER PRICE INDEX (CPI) FOR JUNE, 2020.

The CPI Year-On-Year Inflation Rate for Kaduna State accelerated to 11.89% in June, 2020. This was 0.50% higher than the rate recorded in May, 2020 (11.39%).

Accordingly, Inflation continued in June due to Covid-19 Pandemic and the rise in prices of Bread and Cereals, Potatoes, Yam and Other Tuber, Fruits, Oil and Fats, Meat, Fish and Vegetable.

This simply means that the purchasing power of the consumers has deteriorated and the ability of the consumers to afford the same quantity of good and services has reduced significantly.

The CPI Month – on – Month basis in Kaduna State shows that the State Index stands at 204.99% in June 2020. The urban Index recorded 206.06% while rural index recorded 206.89% in June 2020 respectively.

The State CPI Month – on - Month Inflation rate was 13.12% in June 2020, up by 0.78% from 12.34% recorded in May 2020. The Urban Inflation Rate was 17.79% in June 2020, increased by 0.63% from 17.16% recorded in May 2020. The Rural Inflation Rate was 12.55% in June 2020, increased by 0.46% from 12.09% recorded in May 2020.

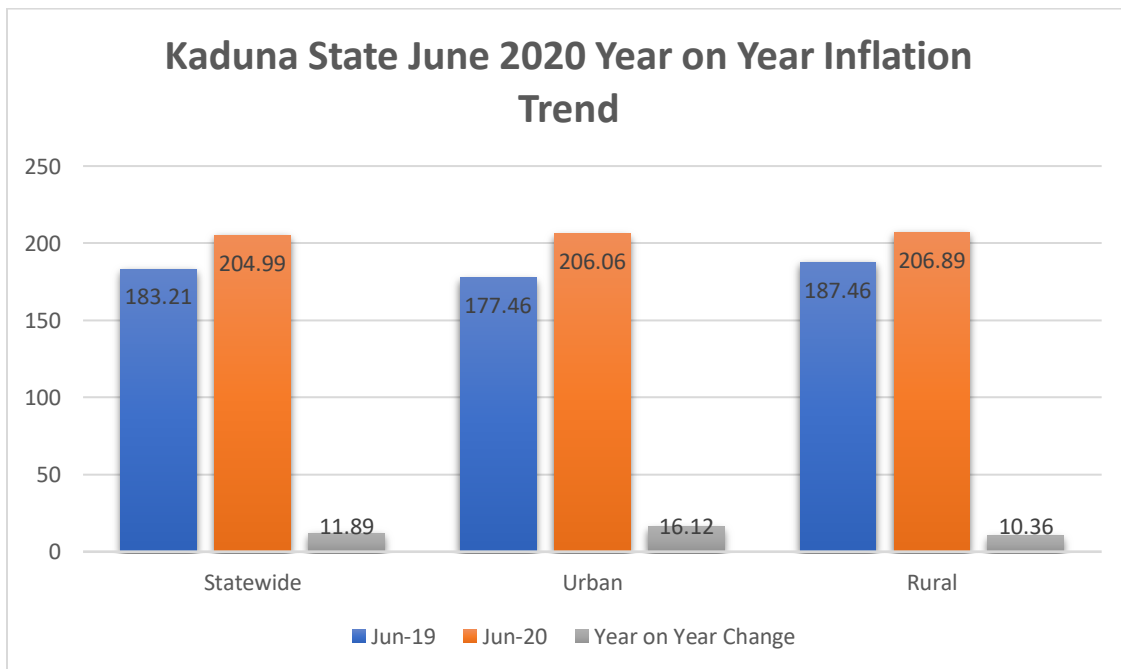
The Increase of the Month-on-Month Inflation rate in June 2020 was as a result of Increase in prices of Bread and Cereals, Potatoes, Yam and Other Tuber, Oil and Fats, Meat and Fish.

The Top Five Absolute contribution that influenced the Increase of the Month-on-Month February CPI Inflation Rate included: Bread and Cereals 6.79%, Potatoes, Yam and Other Tuber 1.67%, Oil and Fats 1.46%, Meat 1.07% and Fish 1.04%.

The highest contribution to the Increase of June 2020 Month-on-Month Inflation rate was recorded in Bread and Cereals 6.79%.

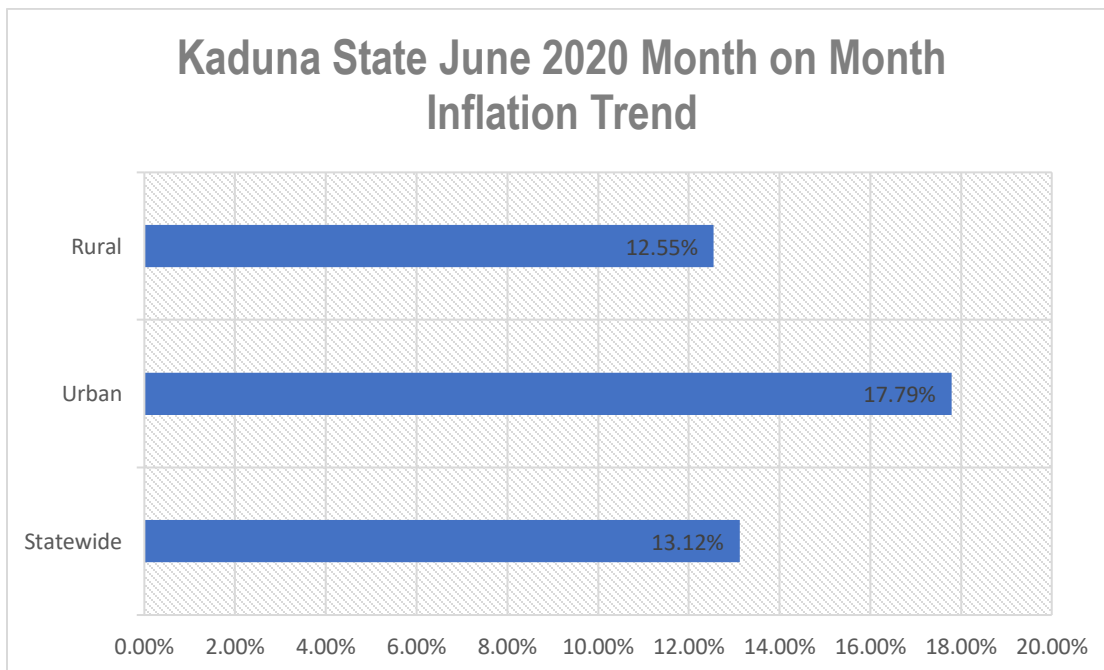
